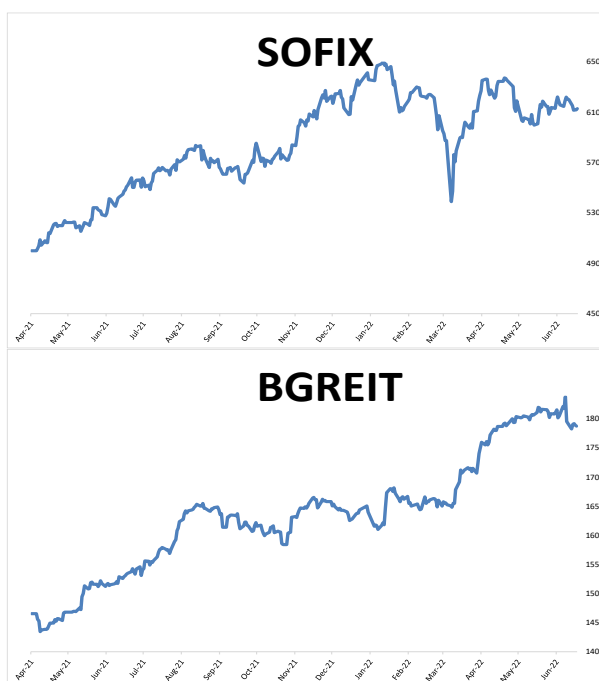

Market Overview (13th June – 17th June)

The main Bulgarian index **SOFIX** decreased by 1.17% this week, down to 612.79 points. The broad index **BGBX40** decreased by 0.91% to 143.38 points and **BGREIT** decreased this trading week to 178.76 points, down by 0.26%.

Corporate News

Eurohold Bulgaria (EUBG) published its annual results for 2021 showing revenues increasing 157% to BGN 3.66bn and Net Income increasing 189% to BGN 63mln, while having BGN 3.8bn assets. The results are due to the acquisition of the business of CEZ Bulgaria in early 2021, the electricity distribution company.

Bulgartabac (BTH) published its annual results for 2021 showing over 44% increase in revenues. This was due primarily to the sale of land and buildings from the portfolio of the company, and minor decreases of some of the operational expenses.

Telelink Business Services Group (TBS) announced a dividend to its subsidiary Telelink Business Services EAD in the amount of BGN 10.4 mln.

Sopharma Properties (SFI) announced dividend for 0.166 BGN/share for a total of BGN 3.6mln.

EMKA AD (EMKA) announced dividend for 0.15789 BGN/share for a total of BGN 3.4mln.

Monbat AD (MONB) announced dividend for 0.14 BGN/share for a total of BGN 5.5mln.

Allterco (A4L) announced financing to their subsidiary in the US in the amount of USD 1.5mln, where 0.5mln would go to increase owners capital and the rest would be a 1 year loan.

Economic News

➤ Bulgaria's inflation (annual) increased to 15.6% reaching a 24 year high. The greatest contribution was from food and non-alcoholic beverages, housing and transportation.

➤ Bulgaria's trade deficit rose sharply to BGN 713.5mln in April from BGN 176mln in the same month in 2021. Imports jumped 37.5% to BGN 8,362mln, near to their all-time high of BGN 8,960mln reached last month. Exports rose 29.5% to BGN 7,648mln, but it also fell from its all-time high reached last month at BGN 8,097.

➤ Bulgaria's current account surplus widened to EUR 163 million in April of 2022 from EUR 86.9 million in the corresponding month of the previous year.
